NOTICE OF THE FIRST MEETING OF CREDITORS

NOTICE IS HEREBY GIVEN that a First Meeting of the Creditors of the Company in the above matter will be held as a physical meeting on 18 January 2023 at 9:00 am (Bermuda time) / 9:00 pm (Hong Kong time) (the "**Meeting**") to consider resolutions:

- (i) to appoint Permanent Liquidator(s);
- (ii) to determine whether or not a Committee of Inspection ("**Committee of Inspection**") is to be appointed to act with the Permanent Liquidator(s), and if so, who will be the elected members of the Committee of Inspection; and
- (iii) to determine whether the Committee of Inspection should be composed of no less than three and no more than five persons, and in the event that more than five persons are nominated, that the five persons receiving the greatest proportion in value voting in favour of their nomination shall be appointed to the Committee of Inspection.

NOTICE IS HEREBY GIVEN that the Meeting will be held concurrently at both 14/F, Fairmont House, 8 Cotton Tree Drive, Central, Hong Kong and 3rd Floor, 5 Reid Street, Hamilton HM 11, Bermuda.

NOTICE IS HEREBY GIVEN that the creditors of the above named Company are required on or before 11 January 2023 to submit their names and addresses, and their proof of debts or claims, to the undersigned, the Joint Provisional Liquidators of the said Company, at the offices of R&H Services Limited, 3rd Floor, 5 Reid Street, Hamilton HM 11, Bermuda, to be eligible to attend and vote at the meeting.

At the first meeting of the creditors they may amongst other things —

1 By resolution determine whether or not an application is to be made to the court to appoint a liquidator in place of the Official Receiver or provisional liquidator.

2 By resolution determine whether or not an application shall be made to the court for the appointment of a committee of inspection to act with the liquidator, and who are to be the members of the committee if appointed.

NOTE: If a liquidator is not appointed by the Court the Official Receiver or provisional liquidator will be the liquidator.
