NOTICE OF ADJOURNED DISSOLUTION HEARING

UPON the Order of the Grand Court of the Cayman Islands (the "**Grand Court**") dated 22 February 2022, whereby GTI Holdings Limited (In Official Liquidation) (the "**Company**") was placed into official liquidation.

AND UPON Mr. Lai Wing Lun and Mr. Osman Mohammed Arab, both of Acclime Corporate Advisory (Hong Kong) Limited, 10/F, Lee Garden Three, 1 Sunning Road, Causeway Bay, Hong Kong, and Mr. Owen Walker, of R&H Restructuring (Cayman) Ltd., Windward 1, Regatta Office Park, PO Box 897, Grand Cayman KY1-1103, Cayman Islands, being appointed as joint official liquidators of the Company (the "**Joint Official Liquidators**") by Order of the Grand Court dated 22 February 2022.

AND UPON the application by way of Summons dated 24 October 2025 of the Joint Official Liquidators for an order for the Joint Official Liquidators' discharge from office and the dissolution of the Company pursuant to section 152 of the Companies Act (2026 Revision) (the "**Dissolution Summons**").

AND UPON the application by Summons dated 9 January 2026 of the Joint Official Liquidators seeking an adjournment of the hearing of the Dissolution Summons.

AND UPON the Order of the Grand Court dated 15 January 2026, whereby the hearing of the Dissolution Summons was adjourned.

AND UPON the Order of the Grand Court dated 29 May 2026, whereby the hearing of the Dissolution Summons was further adjourned to 21 January 2027.

AND UPON the two Orders of the High Court of the Hong Kong Special Administrative Region (the “**Hong Kong Court**”), both dated 30 July 2026, whereby it was ordered that the Company’s Joint and Several Liquidators appointed by the Hong Kong Court be released and the Company be dissolved.

AND UPON the Joint Official Liquidators filing the Twentieth Affirmation of Lai Wing Lun and a letter of request with the Grand Court on 12 August 2026 seeking a re-listing of the hearing of the Dissolution Summons to a date earlier than 21 January 2027.

TAKE NOTICE THAT the Dissolution Summons has been re-listed for hearing before the Grand Court on 3 November 2026 at 10.00 am (Cayman Islands time).

AND FURTHER TAKE NOTICE THAT any creditor of the Company who intends to appear and be heard in respect of the Dissolution Summons should notify the Joint Official Liquidators of their intention to do so within 14 days of the date of the hearing of the adjourned Dissolution Summons, that is, by 20 October 2026.
